5. The bidding documents and general conditions of the contract, Seek Clarification Start Date is 17-01-2018, (10 AM) and Seek Clarification End Date is 25-01-2018, (12 Noon).
6. The Technical bids uploaded on the website up to due date and time will be opened on **01-02-2018 (11.00 AM)** in the **office of the Executive Engineer, Ravi Canal Construction Lower Division Hiranagar**, in presence of the bidders who wish to attend. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
7. **Instructions to bidders regarding e-tendering process & General conditions of contract.**
 - a) The interested bidder can download the bidding documents from the website <http://www.jktenders.gov.in>
 - b) The bidders are advised to download bid submission manual for the help of Bid submission process from the “Download” option as well as from “Bidders manual Kit” on website <http://www.jktenders.gov.in>
 - c) To participate in on line bidding process, bidders have to get (DSC) “Digital Signature Certificate” as per Information Technology Act-2000. This Certificate will be required for digitally signing the bid. Bidders can get above mentioned digital certificate from any approved vendors. The Bidders, who already possess valid (DSC) Digital Signature Certificate, need not procure new Digital Signature Certificate.
 - d) The bidders have to submit their bids online in electronic format with Digital Signature. The bids cannot be uploaded without Digital Signature. No proposal will be accepted in physical form.
 - e) Bids will be opened online as per time schedule mentioned in the NIT.
 - f) Before submission of online bids, bidders must ensure that scanned copies of all the necessary documents have been attached with bid. Note:- **Bidders are advised to scan their documents at 100 DPI (Dots per Inch) resolution with Black and White, JPEG Scan properly**, convert scanned images to PDF.
 - g) The department will not be responsible for delay in online submission of bids for whatsoever reasons.
 - h) All the required information for bid must be filled and submitted online.
 - i) Bidders should get ready with the scanned copies of cost of documents & EMD as specified in the tender documents.
 - j) The original instruments in respect of cost of documents, EMD are submitted to the Tender Inviting Authority by Registered post/Speed post/Courier as per time schedule specified i.e. 30-01-2018 **up to 02 PM.**
 - k) In case the bid is found unreasonable i.e. 15 % below the advertised cost, the bidder shall have to submit additional security of 5 % (which shall be released only after completion of 70% of the work) of advertised amount in shape of FDR/CDR in advance before the last date of submission of the bid, failing which the tender shall be rejected.
 - l) No extra lead, lift or carriage of any materials and dewatering shall be paid other than as advertised even if involved at site.
 - m) In case the contractor does not start the work within the stipulated time, the same shall be got executed through some other contractor/agency at his risk and cost after notifying the contractor/agency through daily newspaper.
 - n) In case of any error if found in the rate list or in the agreement due to type, over sight in respect of rates, Quantities or in units etc., the same shall be corrected and paid to the contractor as per new sanctioned Schedule of rates of 2012 with contractor’s allotted tender appreciation/depreciation.
 - o) Any item or items of work if found necessary during execution at site, though not advertised shall have to be executed by the contractor and shall be paid as per Sanctioned Schedule of rates of 2012 with contractor’s allotted tender appreciation/depreciation.
 - p) The rates are inclusive of toll tax, royalty, sales tax, octroi charges and any local taxes to be paid by the contractor in bringing of materials to the site of work.
 - q) The classification of earth work is fixed and not subject to any variation met during execution. No claim whatever shall be entertained regarding change in classification by the department.

- r) The total period of completion shall be as mentioned against each work including rainy days for the complete work from the date of issue of letter of allotment/Intent of contract.
- s) The deposit at the rate of 10% of the total value of the bill shall be deducted as security deposit.
- t) Defect liability period of one year shall be reckoned from the date of completion of work certified by the Executive Engineer. The contractor shall be responsible to make good (at his own expenses) any defect which may develop or may be noticed within one year after the date of completion which is attributable to the contractor.
- u) Service Tax/Sales Tax/Labour Cess: - The rates quoted by the contractor shall be deemed to be inclusive of the service tax, sales tax, labour cess and levies etc. applicable in the J&K State shall be deducted from the contractor's bill.
- v) Time of Completion: The contractor is bound to complete the allotted work with in stipulated completion period as mentioned in the NIT including rainy days because of restricted/limited canal closure period, failing which penalty to the extent of 10% of total value of bill as determined by the Executive Engineer can be imposed upon the contractor by the next higher authorities.
- w) All terms and conditions executed by the contractor with the department and also that of PWD Form 25 shall be binding upon the contractor.
- x) The payment shall be made only for completed length of canal/Disty/Minor/Sub-Minor/ job executed by the contractor and no payment shall be entertained for incomplete length/Job.
- y) The cement shall be issued to the contractor against Indents on cash payment of Rs. 460/- per bag as per availability in the divisional Store. In case the cement is not available in the Divl. store, the contractor has to purchase from the market after obtaining the necessary NOC from the I/C Store officer as per prescribed specifications i.e. A.C.C, Ambuja, Ultra Tech, Shree ultra & Birla plus conforming to ISI. The steel shall be issued from the division cost of which shall be recovered from the payment of the contractor @ **Rs.6000/-Qtl.**
- z) The contractor will provide cubes/modules of 15x15x15cm during the execution of the work which are required for casting of cubes for C. Conc. being used by the contractor on the work by the I/C JE/AEE and get them tested to know seven days and twenty eight days test from the Designs inspections and Quality Control Department (J & K) Jammu to ascertain the quality of cement concrete. The expenditure for testing of cubes shall be borne by the contractor. Satisfactory results are mandatory for making the payment to the contractor.
- aa) The details of cost of documents, EMD specified in the tender documents should be the same as submitted online (Scanned copies) otherwise bid will not be accepted.
- bb) Bidders can contact the office of the Chief Engineer RTIC Jammu or concerned Executive Engineer or NIC authorities for any guidance for getting DSC or any other relevant details in respect of e-tendering process.
- cc) Bidders are advised to use “**My documents**” area in their user profile on <http://www.jktenders.gov.in> e-tendering portal to store important documents like Experience certificate, Balance sheet, VAT Certificate, Sales Tax Certificate, IT Certificate, Manufacturers authorization and other related documents etc. and attach these certificates as Non Statutory documents while submitting their bids.
- dd) Bidders are advised not to make any change in BOQ (Bill of Quantities), Technical and commercial contents or its names. In no case they should attempt to create similar BOQ manually. The BOQ downloaded should be used for filling the rates and taxes and it should be saved with the name as contains the guidelines for submission of bid online can be downloaded from the website <http://www.jktenders.gov.in>
- ee) Original Documents of any bidder if required at any point of time shall be called for by the department before opening of the financial bid or allotment of work.
- ff) Allotment of work to the contractor subject to the availability of funds under appropriate head /Scheme
- gg) Executive Engineer RCC Lower Division Hiranagar reserves the right to reject any tender or any part of the tender without assigning any reason(s) thereof.

- hh) The tender inviting and opening authority is Executive Engineer of RCC Lower Division Hiranagar.
- ii) Bids cannot be uploaded after the time and date for receipt of bids as set out in the invitation of Bid.
- jj) Owner reserves the right to accept or reject any or all bids without assigning any reason for such a decision.
- kk) All the cost and expenses incidental to preparation of the proposals, discussions and conferences, if any, including pre-award discussions with the owner, technical and other presentation including any demonstrations etc. shall be to the account of the bidder and owner shall bear no liability what so ever for such costs and expenses.
- ll) The work shall be allotted to the lowest bidder, fulfilling all conditions, only after availability of funds with the department for the said work under specified programme.
